



- JOB DESCRIPTION:** RGN/RMN to work in a 30 bedded home for older people with a functional mental illness.
- BASE** The Hamlets Nursing Home, Merseyparks, 99 Mill Street Liverpool, L8
- RESPONSIBILITIES:** To assist in the day to day running of a home for thirty older people with a functional mental illness.
- SALARY:** Up to £24\* per hour depending on experience with **5.6** working weeks' holiday (including bank holiday allowance) plus additional payment for on call.  
\*Please note that the rate of £24 per hour has been provisionally agreed with our board until the end of February. At this point the rate will be reviewed and may decrease
- Annual NMC Registration fee and annual subscription to NT Portfolio to assist with 3 yearly NMC revalidation will be added to the salary.

The home is an integral part of a network of services provided by Age Concern Liverpool and Sefton and all staff are expected to participate in and benefit from other Age Concern activities.

**The RGN/RMN:**

1. Will be accountable to the Home Manager to assist in the efficient day-to-day running of the home to a standard set by the Care Quality Commission, Age Concern Liverpool and Sefton or any other regulatory authority.
2. Will ensure, through a team including employees, volunteers, guardians, advocates and representatives from statutory and non-statutory organisations that each service user lives in a home environment which fosters security, personal dignity and privacy.

3. Will foster an environment that promotes the individual care of service users.
4. Will assist in the maintenance of personal records on each service user.
5. Will act as Key worker to a group of residents. Develop person centred care plans and risk assessments with the service users, the multi-disciplinary team and the families.
6. Will review care plans and risk assessments each month and if there are any changes.
7. Will assist in the administration and safe-keeping of drugs for which the home has taken responsibility and the maintenance of necessary records.
8. Will be involved with staff and residents in the day-to-day running of the home including personal care, health and safety and infection control.
9. Will be involved in supervisions for care/domestic staff
10. Will ensure that each service user has the opportunity to develop their skills and abilities through guidance, education and social support to maximise their personal independence.
11. Will actively participate in staff meetings, service user's meetings and staff training as required.
12. Will act at all times within the policies and procedures of Age Concern Liverpool & Sefton.
13. Will be required, in the absence of the Home Manager to be responsible for the efficient day-to-day running of the home to a standard set by the Care Quality Commission.
14. Will participate in the 'on-call' rota with other nursing staff
- 15.. Will carry out any other duties as required by the Chief Executive of Age Concern Liverpool & Sefton
